Boiler Report: Final inspection of our new boiler installation determined that the existing gas service into the DC is via a high pressure gas line. The gas pressure was then reduced at the boilers with a series of regulators. This is not code. Because our existing gas meter and aspects of our gas line infrastructure are designed for a low pressure service, we have been issued a "notice of violation" with the SF Building Department. The Building Committee is working in conjunction with PG&E and the Building Department to correct the gas service. This will include installing a new utility vault and high pressure gas meter under our sidewalk, necessary regulators, moving some gas lines and evaluating the suitability of our existing network of gas lines for the reengineered system. PG&E estimates from 5 weeks to 6 months engineer and install the new meter and network. In the interim, we will be able to use boilers and stoves; all other gas systems will be shut down.
